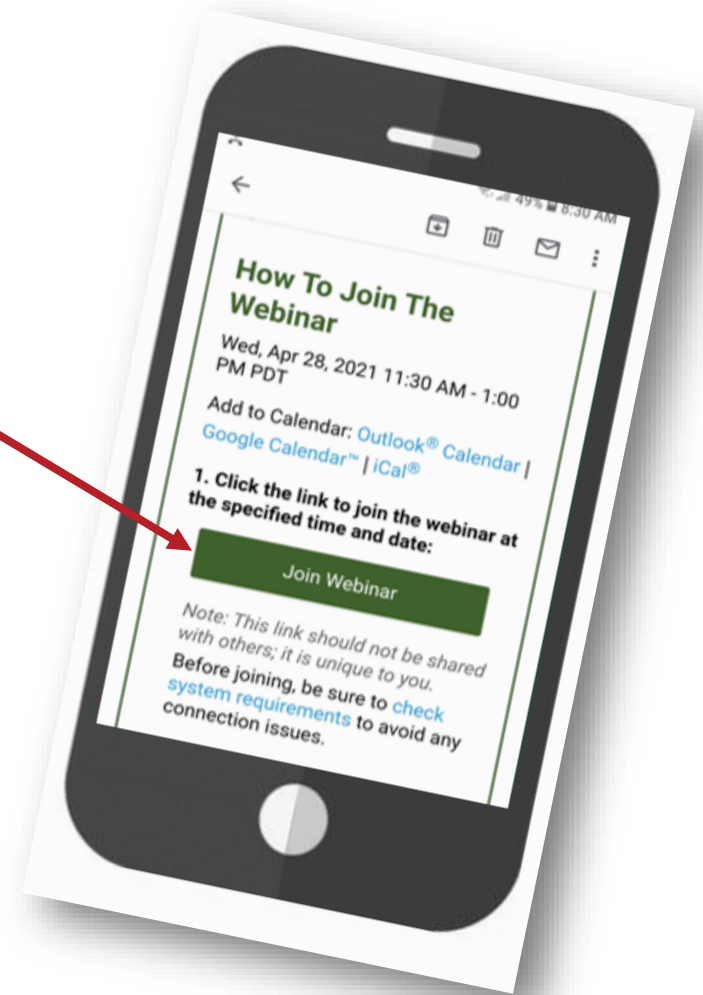





Top 10 Questions & Answers

Q4: For the CD-511 Certification Regarding Lobbying, the entire Funding Opportunity Number (“NTIA-TBC-TBCPO-2021-2006948”) does not fit in the Award Number field. What should I do?

A: NTIA acknowledges that the full Funding Opportunity Number may not fit within the applicable field in the CD-511 form. Applicants should either: (1) type out as much of the NOFO name as they can until the field is completely filled; or (2) use the abbreviation “NTIA-TBCP-2021.”

Top 10 Questions & Answers

Q5: When completing the federal forms and programmatic documentation, where do I enter the total project costs?

A: The total federal budget amount required for the entire proposed project that is entered in SF-424, SF-424A or SF-424C, budget narrative, and budget justification should all match. If you are applying for both the Broadband Infrastructure Deployment and Broadband Use and Adoption projects, the total project costs is the sum of the totals of SF-424A and SF-424C.

In the SF-424, item 18 should list the total federal budget amount requested for the entire project.

Top 10 Questions & Answers

Q6: If I am not required to submit one of the SF-424 forms listed under Mandatory Forms in grants.gov, will the system allow me to submit my application? Also, if I am required to submit one of the forms under Optional Forms, do I still need to submit?

A: Yes. Only submit the required forms that apply to the project type you are applying for as outlined in the NOFO. If one of the forms is listed under Optional Forms is listed as a required form in the NOFO, you must submit it.

Top 10 Questions & Answers

**Q7: What is included in the administrative and legal cost classification?
What is the cap on this cost classification?**

A: Administrative expenses include costs attributable to: accounting, auditing, contracting, budgeting, and general legal services; facility occupancy costs (e.g., rent, utilities, insurance, taxes, and maintenance); general liability insurance that protects the organization (not directly related to a program); depreciation on buildings and equipment; general office supplies; and general and administrative salaries and wages.

Tribal Broadband Connectivity Program grantees may not expend more than 2% of the total funds received on administrative expenses.

Top 10 Questions & Answers

Q8: How should I classify personnel time in the SF-424C budget form?

A: If staff are completing administrative or legal functions, such as accounting, auditing, contracting, budgeting, and general legal services, their time for these activities should be listed in the admin and legal cost classification.

If staff are completing activities associated directly with the project, they should account for their time in that specific cost classification. For example, if conducting activities directly related to construction, the time spent on those activities should be listed in the construction cost classification.

Top 10 Questions & Answers

Q9: How should I classify my planning, sustainability and feasibility studies in the SF-424C budget form? What is the funding cap on this activity?

A: Applicant should put costs associated with their planning, sustainability, and feasibility study in the miscellaneous cost classification.

The costs of planning, feasibility, and sustainability studies may not exceed one percent (1%) of the total project cost.

Top 10 Questions & Answers

Q10: Does NTIA have a specific percentage applicants should use for contingency costs in line 13 of the SF-424C?

A: An applicant may include contingency in budget estimates to the extent they are necessary to improve the precision of those estimates. Amounts for major project scope changes, unforeseen risks, or extraordinary events may not be included. Amounts must be estimated using broadly-accepted cost estimating methodologies, specified in the budget documentation of the Federal award, and accepted by the Federal awarding agency. See 2 C.F.R. § 200.433(b). In order for actual costs incurred to be allowable, they must: comply with the cost principles and other requirements in this part (see also 2 C.F.R. §§ 200.300 and 200.403); be necessary and reasonable for proper and efficient accomplishment of project or program objectives; and be verifiable from the non-Federal entity's records. See 2 C.F.R. § 200.433(b).

NTIA has not determined a specific percentage that applicants should use for contingencies. NTIA notes that contingencies are generally considered reasonable if they are 10-15% of construction costs or less, otherwise the applicant should provide justification for the higher costs.

NTIA is committed to increasing broadband Internet access across America, particularly in unserved and underserved communities. BroadbandUSA and NTIA serve federally recognized tribal governments and Hawaiian home lands that seek to expand broadband connectivity and promote digital inclusion through solution-neutral guides and resources, group technical assistance, interagency coordination, and administration of grant programs.

Tribal Broadband Connectivity Program (TBCP)

The Consolidated Appropriations Act, 2021, provides new sources of tribal broadband funding to assist in mitigating the effects of the COVID-19 pandemic which is exacerbating the digital divide across Indian Country. With the designated funding, NTIA is developing the Tribal Broadband Connectivity Program (TBCP), a \$1 billion program directed to tribal governments to be used for broadband deployment on tribal lands, as well as for telehealth, distance learning, broadband affordability, and digital inclusion. Entities eligible for TBCP grants include tribal governments, tribal organizations, TCUs, the Native Hawaiian Community, and Native Corporations.
