She's also a citizen of the Navajo Nation born and raised in Shiprock, New Mexico. She currently resides in Sacramento, California.

She has more than 20 years of experience in public health management, a Master of Social Work degree from Washington University in St. Louis, and a Master of Public Administration degree from the University of Southern California.

Crystal Hottowe comes to us from the Makah Tribe located in Washington State, for 12 years Crystal served as the grants writer for her tribe with a focus on state and federal grants. In addition to her grant writing duties, Crystal is also detailed to the Makah Tribal Broadband Project, which entailed not only a wireless network deployment, but also negotiations with industry. She was very active with the national, regional, and statewide policy groups.

Nicholas Courtney is an enrolled member of the Makah Tribe. Nick earned his Bachelor and Master's degrees from Western Washington University in Bellingham, Washington, and was raised in Auburn, Washington on Muckleshoot Tribal Lands. Before joining us at NTIA, Nicholas served as the Director of Policy at the National Congress of American Indians, serving the broad interests of tribal governments and communities. Previous to working at NCAI, Nicholas served as program director for the Native American Political Leadership Program at George Washington University.

Adam Geisler is a national tribal government liaison with the First Responder Network Authority, serving western tribes in FEMA Regions 9 and 10. He is a member of the La Jolla Band of Luiseno Indians near San Diego, California, and has served in an elected leadership role with his tribe running tribal government and shaping national policy and public health, transportation, economic development, and housing for over a decade.

He has led his tribe through four federally declared disasters, has served as vice chairman and founding board member of the inter-tribal Long Term Recovery Foundation (a disaster response and recovery organization), and is a recipient of the International Wireless Communications under 40 Leadership Award.

Gabe Montoya is an enrolled member of the Pueblo of Pojoaque located in northern New Mexico. He has served on tribal council for 27 years, and on the Board of Directors for the Tribe's Economic Development. He brings over 10 years of experience in Tribal broadband to NTIA, including his service as a board member and chairman for Redi-Net, regional multi governmental JPA collaboration, which was set on bridging the digital divide to bring broadband services at affordable prices to their constituencies for the good of their communities.

My name is Margaret Gutierrez, and I will be your moderator. I'm an enrolled member of the Citizen Potawatomi Nation. I spent 10 years with the Agua Caliente Band of Cahuilla Indians as the Director of Emergency Services. I am the first Native American graduate at the Naval Postgraduate School Center for Homeland Defense and Security Program. I hold a master's degree in security studies. I'm a professor in the School of Criminology, Criminal Justice, and Emergency Management at Cal State University Long Beach. I'm a national tribal liaison for FirstNet, and I serve as the principal point of contact for tribes and FirstNet FEMA regions 1-8. I am currently on detail to NTIA working on the Tribal Broadband Connectivity Grant Program.

Today's agenda, we'll review the top 10 questions regarding the Tribal Broadband Connectivity Grant Program, review the BroadbandUSA, Tribal Resources, and then some time for question and answers at the end. And with that, I will turn it over to Nick to kick off our top questions and answers.

Nicholas Courtney

Thank you for that introduction, Margaret, and good morning, and good afternoon. My name is Nicholas Courtney. Our first question is, where can I find the SF-424 Forms if I choose to mail or e-mail in my application?

6:04

The answer is, regardless of whether you e-mail or mail in your application, you can find all the SF-424 forms by visiting the grants.gov website at grants.gov. Once you get to grants.gov, you will see on the top bar, there is a menu item called "forms", as illustrated by the red arrow on your screen. When you hover over the word forms, a drop-down menu will appear. Once this happens, you want to select the SF-424 Family, again, as illustrated by the red arrow on your screen. This will bring you to a menu of forms, some of which are required for the Tribal Broadband Connectivity Program application.

A note that the image on your screen does not show all of the forms available under the SF-424 family, and it is simply a snapshot of those that would fit in the image for this presentation. You can also access this page directly by visiting grants.gov/web/grants/forms/SF-424-family.html.

This brings us to our next question, which is, what federal forms are mandatory for the Tribal Broadband Connectivity Program?

7:40

You can see that the answer to this question depends on which project an eligible entity is applying for, which can be split into 1 of 3 options. The first option is for applicants applying for just broadband use and adoption projects. For this option, an applicant will need to fill out the SF-424, the SF-424A, the SF-424B, CD-511 and the standard form, SF-LLL. For those applying for broadband infrastructure deployment projects only, you will need to fill out the SF-424, the SF-424C, the SF-424D, the CD-511, and the standard form LLL.

For those applicants, applying for both broadband use and adoption projects, and broadband infrastructure deployment projects, you'll need to fill out all forms, including the SF-424, the SF-424A, the SF-424B, the SF-424C, The SF-424D, the CD-511, and the standard form LLL.

With that, I will now turn it over to my colleague, Vanessa for the next question.

Thank you, Nicholas. Now, for the third question, what programmatic and budget documents are required? So, if you're applying for only the broadband use and adoption project, you will include a project narrative, resumes of key personnel, a budget narrative with detailed budget justification, your indirect cost rate, if that's applicable, documentation and showing status as an eligible entity.

Any if you're applying for only the broadband infrastructure deployment project, you will include your project narrative, your resumes of key personnel, your budget narrative, and detailed justification, the indirect cost rate, if that's applicable, documentation showing status as an eligible entity, a tribal resolution, and maps of proposed service areas. If you're planning to apply for both types of projects, you will include all of these items that are listed above on the chart.

For question number four, for the CD-511 Certification Regarding Lobbying Form, the entire Funding Opportunity Number does not fit in the award number field. What should I do?

We acknowledge that the full opportunity number may not fit within the applicable field in the CD-511 form. Applicants can do 1 of 2 things. They can (1), type that, as much of the NOFO name as they can until the field is completely filled; or (2) use the abbreviation, "NTIA -TBCP-2021."

Next, I'm going to hand it off to Crystal.

Thanks Vanessa. Question five. When completing federal forms and programmatic documentation, where do I enter the total project cost?

11:09

Well, the answer to that, the total federal budget amount required for the entire proposed project that has entered in SF-424, SF-424A or SF-424C, budget narrative, and budget justification should all match. If you're applying for both the broadband infrastructure deployment and the broadband use and adoption project, the total cost project is the sum of the total of SF-424A and SF-424C. In

the SF-424 item 18 should lift the total federal budget amount requested for the entire project.

Question six. If I am not required to submit one of the SF-424 form listed under mandatory forms in grants.gov, will the system allow me to submit my application? Also, if I'm required to submit one of the forms under Optional Forms, do I still need to submit?

Well, the answer to that is yes. You're going to only submit the required forms that apply to the project type you are applying for as outlined in the NOFO. If one of the forms under Optional Forms is listed as a required form in the NOFO you must then submit it.

Thank you. And I'm going to pass it on over to Adam at this time.

All right, well thanks for that Crystal. All right. Well, let's go on to question number seven. So what is included in the administrative and legal cost classification? And what is the cap on this cost classification?

12:50

So let's talk about the answer. Administrative expenses include costs attributable to accounting, auditing, contracting, budgeting, and general legal services, facility occupancy costs, ergo, rent, utilities, insurance, taxes, and maintenance.

13:10

Also, general liability insurance that protects the organization not directly related to a program, depreciation on buildings and equipment, general office supplies, and general and administrative salaries and wages. Note: Tribal broadband connectivity program grantees may not expend more than 2% of the total funds received on administrative expenses. All right, questioning.

13:38

So, how should I classify personnel time and the SF-424C budget form?

13:44

Here's the answer. If staff are completing administrative or legal function, such as accounting, auditing, contracting, budgeting, and general legal services, their time for these activities should be listed in the admin and legal cost classification. If staff were completing activities associated directly with the project, they should account for their time in that specific cost classification.

For example, if conducting activities directly related to construction, the time spent on those activities should be listed in the construction cost classification.

Alright, I'm going to go ahead and hand it over to Mr. Gabriel Montoya, OK.

Thank you, Adam. Much appreciated.

14:30

Good afternoon. My name is Gabriel Montoya. We're going to go over a couple of questions.

14:34

How should I classify my planning, sustainability and feasibility studies in the SF-424C budget form? What is the funding cap on this activity?

14:45

Applicants should book costs associated with the planning, sustainability, and feasibility study in the miscellaneous cost classification. The costs of planning, feasibility, and sustainability studies may not exceed more than 1% of the total project cost.

15:00

Does NTIA have a specific percentage applicants should use for contingency costs in line 13 of the SF-424C?

15:10

An applicant may include contingency in a budget estimate to the extent that they are necessary to improve the precision of those estimates. Amounts for those major project scope changes, unforeseen risks, or extraordinary events may not be included. Amounts must be estimated using broadly accepted cost, and estimated methodologies specified in the budget documentation of the Federal Award and accepted by the federal awarding agency. Please see 2 C.F.R. 200.433(b). In order for actual costs incurred to be allowable, they must comply with the cost principles and other requirements in this part.

See, also 2 C.F.R.300 and 200.403; be necessary and reasonable for the proper inefficient accomplishment of the project or program objectives. And verifiable from non-federal entities records. See 2 C.F.R.200.433(b). NTIA has not determine the specific percentage that applicants should use for contingencies, NTIA notes that contingencies are generally considered reasonable, if they are 10 to 15% of construction costs are less, otherwise, the applicants should provide justification for the higher costs.

I want to thank our TBCP team for reviewing our top 10 questions and answers. We will now briefly go over some important resources on our BroadbandUSA website. For a full copy of the NOFO, as well as our latest FAQs and webinar recordings, transcripts, and presentations, you can visit our Tribal Broadband Connectivity webpage on our BroadbandUSA website.

You can find that by going to our homepage, going to the Grants Program tab, and selecting Tribal Broadband Connectivity, as you can see, highlighted by the arrow on your screen.

We would also like to highlight our Tribal Nations page under our Resources tab. On this page, you will find information about the TBCP, additional resources of interest to tribes looking to develop and implement their own broadband connectivity and digital inclusion programs, as well as contact information for our entire TBCP team.

We will now begin the question-and-answer part of the webinar, if you haven't already done so please remember to type your questions or comments into the question box on the right-hand side of the screen. We will try to get through as many as we can.

All right, good afternoon, and I want to make sure everyone can hear me OK.

18:06

You can, yeah, OK, Margaret checked, yes, before we jump into questions, Adam, is there anything you would like to mention before we start?

Yeah, a couple of points.

Adam Geisler

18:20

I already see some of the questions coming in that are relevant in the chat, but we'll cover this.

18:25

We do a poll every morning of the grants.gov to see how many applications we have in the system and while

18:33

I cannot give you the number today.

18:35

I can say that there are a significant number of applications that are sitting in the system that have yet to be formally submitted.

18:43

So we just wanted to remind everybody that if you are planning on submitting your application, you do need to actually hit the submit button for the application.

18:52

Uploading your forms into grants.gov alone does not equate to a submission. You actually need to formally submit the application through the system, so we just wanted to remind everybody.

19:04

For those of you that have been working on an application, or you think you submitted an application, please go double check that you hit the Submit button for your application in grants.gov.

19:16

All right, The second item here, for what it's worth, guys.

19:20

This topic of conversation doesn't bring anybody on the team, any pleasure, but it's the reality of the environment that we're in.

19:27

And we have been, we've wanted to be as transparent and truthful with you in terms of process that we can.

19:33

And so here's the reality when it comes down to the timeline extension requests that many of you have been asking or inquiring about with regards to the 90 day application window. It is a statutory element, so, this wasn't the brainchild of NTIA.

19:51

This was actually something that was put into HR 133, Section 905, that essentially mandated the timeline, and so we are working on being in compliance with that timeline.

20:04

So I know a number of you are being impacted by natural disasters wildfires,

20:10

Hurricanes, some of your communities are being shut down due to COVID. Some folks aren't even in the office.

20:17

And while we recognize and can truly appreciate the environment that you're in, on a personal level, on a professional level, we want to make it really clear.

20:25

And again, doesn't bring us any joy and saying this, that timeline is, the deadline is September 1st, and so you need to get any form or fashion of your application that you can into us.

20:36

So with that being said, as I just mentioned, any form or fashion of the application that you can get into us, especially if you're being hit with those circumstances.

20:45

We have a mandate to cure applications. We can't cure an application, an application if we don't receive it.

20:53

So please do your best to get what information you have in if you're being impacted by the pandemic or natural disasters and we're going to do our best to cure the applications in the best way that we can.

21:05

Again, if you don't hit submit and turn in the basic documentation needed for the application, there's no way for us to cure it.

21:13

So if you're able to, please look hard at getting that application in and submitted how you can.

21:20

I also want to highlight one last thing.

21:22

There are alternative methods for submission as well, so maybe you're not able to get into the office, but, and, or you can't get to your work e-mail. I'm not sure what your environments are, but remember that you can actually submit via post mail. All that I ask is that you reach out and co-ordinate with me, so we know that it's coming, and that we can co-ordinate the receipt of that application. Again, September 1st is the deadline for the application.

In addition to that, if you're looking at an e-mail submission, you'll also need to coordinate with me as well, and we need to make sure that, again, you are hitting that submission over to us and it's coordinated, and that we receive it prior to this or September first or earlier.

Alright, Margaret. I'm going to turn it back over to you for the rest of the Q&A Thank you.

Thank you, Adam.

22:10

And I see a couple of those questions still come in, I'm going to read them just for the record because people have said that they want to read just for the record.

22:16

So, they will come out again.

22:20

Vanesscia the NOFO indicates page 15 that the SF-424C should be used for the infrastructure portion while the SF-424A should be used for the adoption portion.

22:29

Does this mean the construction cost should only be listed in the infrastructure budget? Even those activities align more closely with adoption as described in the NOFO.

Margaret Gutierrez

Vanesscia Cresci

22:42

Thank you. There are two types of projects within the tribal broadband connectivity program, So, there's the broadband use and adoption, and then a broadband infrastructure deployment project. You will complete the SF-424A to cover all costs associated with the broadband use and adoption project activities, and then you will complete the SF-424C to cover all the costs for your broadband infrastructure deployment project.

Each type of project has different eligible uses and costs, and you can go to page 31 of the NOFO to see a list of eligible uses and costs that are associated with each project.

Thank you.

23:20

Here's another one of those questions, Adam. Adam will the NTIA consider the situation we are in about COVID 19? A lot of tribes are just not coming back to work full-time, will NTIA consider extending the closing date for an extension?

23:32

Considering the deadlines? Most tribes are still dormant.

Adam Geisler

23:36

So Chief, I guess, again, it brings us no joy to have to convey the message, but we have to convey the message.

23:46

And so no, we are not going to be doing any extensions for the tribal broadband program at this time as the windows are statutory.

23:56

And so, as you know, a tribal leader yourself, you recognize that, when I say statutory that as an act of Congress, that, that would take in order to modify that timeline. So again, my apologies, but I also we're going to be a straight shooter. How and when we can hear with what the information is, and that's, that's the truth.

Margaret Gutierrez

24:16

Adam, again, is an operating company subsidiary of an Alaska native corporation eligible to apply?

Adam Geisler

24:24

It depends. So we have basically put the onus on the applicant to identify why they believe they are an eligible entity.

24:34

And, in fact, we ask in both narratives whether you're doing a broadband use and adoption, or a broadband infrastructure proposal, or both we ask that you identify and provide documentation as to why you're an eligible entity.

24:48

And so, I, again, not knowing the details, the organizational structure. I mean, all those pieces that need to be evaluated. I really would encourage you to take a look at the definition of eligible entity on page. I want to say it's page 7 of the NOFO in the definition section.

25:06

It is, and see where your tribal entity fits or if you are a tribal entity, excuse me, an eligible entity. So, so page 7 of the NOFO, again, it's on the applicant to identify why they believe they're eligible for the program.

Thank you.

25:25

Vanesscia, when determining what five resumes to including the application, are key consultants and technical members considered a part of the applicant organization?

25:36

Vanesscia Cresci

Resume should be of key staff of the applicant, not consultant, sub awardees or contractors. Their information can be included in the table of funded project participants. And unfunded inform a collaborator section. So just submit resumes of the applicant.

25:55

Margaret Gutierrez

Nick, is the entire project team evaluated in measuring capacity of an applicant, or is it only the five resumes in the applicant organization?

26:04

Nicholas Courtney

Thanks for that question.

26:06

So, reviewers will assess the strength of our applicants organizational capacity is necessary to undertake and complete the project, and, therefore, reviewers will consider the years of experience and expertise of our project management team. And the past track record of the organization of any sub grantee proposes to use with projects out of similar size and scope, as well as the organizations and individuals and sub grantees, capacity, and readiness.

26:32

We will also assess the strength of the applicant's partnerships or the sub recipient strategy, including how it complements the applicant's organizational capacity, as well as the project approach, feasibility and timely completion of the proposed project. So, if you believe that someone is critical to your teams and to your team's success, please include their resume for justification of an applicant's organizational capacity.

Margaret Gutierrez

Thank you, Nick.

27:03

Again, just for the record, someone else asked if there would be an extended closing date on the grant? I think we've answered that, but I just wanted to read it for the record.

27:10

Vanesscia, can tribes have one combined budget justification and budget narrative for a deployment and adoption and use application?

Vanesscia Cresci

27:24

So, applicants should have a separate budget justification and budget narrative for each of the projects, so one for their broadband infrastructure deployment, and one for the broadband use and adoption. Just as a reminder, you also need to complete the SF-424A for broadband use and adoption projects, and the SF-424C for the broadband infrastructure deployment projects.

Margaret Gutierrez

Thank you.

27:48

Crystal, if a tribal utility is applying on behalf of the tribe, can they use the tribes' grants.gov account or should they create a separate profile?

Crystal Hottowe

27:58

Thank you for that question. So, the NOFO goes into the application submission guidelines, and that's on page 14. But at this point, being about a week away from the deadline, it really, it's best to utilize an account that has already been established, as there are going to be waiting times associated with establishing a new grants.gov profile.

Adam Geisler

28:26

Margaret, I'm just going to chime in on that a little bit more, because that was a good great response, Crystal. I think there's just one more piece we got to identify in terms of who the applicant is, right. So if the telecommunications organization, I think is how it was worded. Say that again, tribal utility.

28:47

So if the tribal utility is basically doing all the legwork but they're applying underneath the tribes' DUNS and EIN, the tribe is the applicant.

28:58

And that means the tribe is on the hook for the reporting and the implementation of the program to be done successfully.

29:05

So we just want to highlight that that, you know, if you're if you're working on an application where you have a utility authority, or a Teleco, or an arm of the Tribe, that's kind of doing the legwork, but you're actually having the tribal government apply that it's the tribal government

29:22

who's responsible for the administration of the programs.

29:25

So, I just Great response, Crystal, but I thought we double down on clarifying just that one piece. So, there's no confusion, because I think I've seen some of these questions come in in the last few days, so, I figured I might as well just get it out there.

29:37

Thanks.

Thank you.

29:40

Vanesscia, in grants.gov and specifically in the attachments file, what file types are allowable, our map shape files are in the zip folder.

29:47

I'm allowed to attach them, but when I downloaded the form and attempted to open it, Adobe restricts my ability to open the zip file that has been attached to the PDF.

Vanesscia Cresci

29:59

There is a file requirement for the attachments, for this funding opportunity. All attachments should be added via the SF-424 under Section 15 of that form there, is a button that reads add attachments.

30:13

You can attach all of your supporting documentation through the SF-424. This will create a zip file that allows for transmittal of the documents electronically via grants.gov.

30:25

More information on the application format can be found on starting on page 23 of the NOFO.

Margaret Gutierrez

30:34

Thank you, Vanesscia.

30:35

Adam, given NTIA has asked for solutions that are future proof and eliminate the digital divide forever. How will large proposals be negotiated?

30:43

Are large proposals that exceed the \$50 million off selling, will NTIA negotiate with the applicant to adjust the scope, or simply not fund the project cost?

Adam Geisler

30:53

I mean, I appreciate the question.

30:57

So, I guess I will just respond with, I guess, we're going to evaluate all proposals in the same manner that is described in the NOFO on page 38.

31:05

So, whether you're applying for, I don't know, \$200,000 or \$200 million, the criteria for evaluation is the same, right? So, levels of need are different and measured.

31:18

And those are some of the things that we look at, but I'm going to point you to page 38 with regards to what we would or would not negotiate. We're not gonna get into that type of what if scenarios right now. And I know a lot of you are trying to hedge your bets, or look for certainty or not ask for more than what you need.

31:37

But again, that this program was meant for you to identify what the solution is, and I think you identified that in your question. Long term, future route, proved scalable, affordable, you mean you guys see all the buzz terms that we have in the NOFO.

31:51

So, without understanding the applications in detail, and we're not going to speak to that too much further. I'll leave one last piece here. We do reserve the ability to negotiate, and also put forth award conditions, that's also outlined in the NOFO as well.

32:10

So, again, a lot of the circumstantial questions, I know this probably isn't the answer that you want.

32:15

But the reality is, is that we haven't had, we don't have your proposals, So, if you're asking it how we're going to evaluate it, it's outlined in the NOFO in terms of what we're looking for, whether it's a small project or a large project. And we reserve the right to, to negotiate and put award conditions on depending on the applicant and the project.

Thank you, Adam.

Nick, when reviewing proposals, do reviewers have experience and costing large telecom projects?

32:43

Nicholas Courtney

Thank you very much for that question. So over the past month, NTIA have examined the aggregate applications based on qualifications that match the needs of this program and recognizing that it is a Broadband Program selecting reviewers who meet those needs. So, yes.

33:04

Margaret Gutierrez

Thank you, Adam, our tribe is in contact with a telecom company that has a submarine cable project that is planned to be completed in 2023. They do not have funds to branch of fiber cable over to our community, but are willing to put a branch, T, along at along the run, and from that, we can build a fiber end

to our community that could serve as our middle mile. This opportunity just reached us last week, and therefore not a lot of time to plan details for the application.

Adam Geisler

I'm trying to understand what the question is.

33:38

So maybe if you don't mind, just elaborating, copy paste and elaborate what the questions that you're asking. I mean, we realize that there's a timeline and a window you've heard.

33:48

I guess I've had to be the bearer of bad news today on this one, which is not fun, but you guys have heard what the timeline is. If here's the other thing that I will encourage, and I'm please elaborate on your question, but I'm going to pontificate for 2 seconds.

Sorry, if you're not at a place to do a full-blown infrastructure project, but you know you want to do something but you don't have all the pieces, I'm going to remind you that you can apply to do feasibility, design, engineering, et cetera.

All the planning activities in order to evaluate what your options are and to address what the costs are and to figure out what your timeline is going to be and to navigate and identify what your permitting issues might be, et cetera.

So, if you feel like you're under the gun and you don't feel like you have enough time to truly go after a broader project, I'm going to encourage you to take a look at applying for feasibility, design, engineering, and evaluation activities for your application.

First off, heart goes out to you, right? I come from a community that has been impacted by wildfires multiple times. So I totally get it, and I think Margaret can appreciate this, too. We have an emergency management background.

We will not be extending the timeline for the application window. Please do everything you can to get whatever fashion or format of an application do you have in the pipe, and we can work on curing the application once we have that in, but again, we're

Example will a reviewer understand that \$500,000 for barging gravel is normal because there is no gravel Or that \$700,000 in helicopter transport for construction crews to the site is normal for middle mile because there are no roads and over land transport will be done with a snow machine or four wheeler and take six hours each way.

You know, I really appreciate this question. You'd be happy to know the NTIA Tribal team has been working on reviewer guidance that is regionally sensitive for those types of construction projects that are going to affect different region.

So, that guidance is being considered and will be provided so your application will be reviewed with that in mind.

Adam, will small tribes leading large consortium efforts be penalized for being small? Example, will a 70-person village lead in a 20 village consortium be eliminated from funding for the perception that they are too small to lead a large effort?

First off, let's, let's just address the first issue here, in terms of being eliminated. Our goal isn't to eliminate any of the applications unless we may eliminate activity's, right? There's no trips to Hawaii allowed in the program. You got it. You got to stick to the program eligible activities that are outlined starting on page 32 of the NOFO.

So, with that being said, you know, we've encouraged consortiums.

We look here, here's a simple answer. But we ask that you use the equipment that's going to serve your community, the best. Look at what's going to be able to get to your people, not. Every solution is going to be a one size fits all.

I'm going to chime in on this one just a little bit because I have a feeling I know where this is coming from and it seems to pop up and I don't blame you for asking.

It seems to come up by both an e-mail and on these in these conversations. It's duplication, guys. Keep in mind that we're gonna fund one solution set, Right?

And so, if you're looking at a, let's see, here, a satellite backhaul solution to be used to connect houses that means that in that solution is providing 25 3, then you have served that home.

So no eligible applicants include a tribal government, B a tribal college or university, C the Department of Hawai'i Homeland's on behalf of the Native Hawaiian community, including Native Hawaiian Education Programs.

D a tribal organization, or E an Alaskan Native corporation. There are several instances where applicants will need to obtain a tribal government resolution. And then each eligible entity must coordinate internally in submitting a single application. If you believe that you fall under the definition of tribal organization. We will take a liability on this and we may have fielded questions during our merit review or during our review process and get back to you. Thank you.

Nick you are not out off the hot seat yet.

45:06

I am a small minority business owner specializing in broadband installation. Do I need to be working with any of the groups identified to benefit in this grant program in order to be able to get the grant?

Nicholas Courtney

The answer is, is yes. You do need to work with eligible entities for the program. Unfortunately, we are unable to share with any entity who has applied to this program, we've received several questions from small minority business owners, large corporations, and such, to get a list of folks and entities that have applied, and unfortunately, we are not able to share this information. So, I would encourage any small minority business owner specializing in broadband installation to certainly be working with an eligible entity of those of which I just discussed.

Nick, again, can a Tribal Health Care Org serve as PI for a consortium of seven tribes for Part A and Part B?

Nicholas Courtney

46:02

Yes, So, a Tribal Health org can serve as a PI for Consortium of seven Tribes. With respect to Part A and B, I don't want to assume anything, but recognizing that there are the infrastructure portion of the Tribal Broadband Connectivity Program, as well as the adoption and use portion. And I would like to remind all listening ears that if an eligible entity is not a tribal government

and applying for infrastructure funds on tribal lands, they will need to obtain a tribal resolution from each of those tribal governments. And if an eligible applicant is applying for adoption and use funding there cannot be duplication on certain on the same projects or on eligible lands. So, the two things to watch out for, if you are not a tribal government and a tribal healthcare org is no duplication. And if you are applying for infrastructure funds, to be working with tribal governments to ensure that there is not duplication of build out.

So, therefore, we encourage you or require you to get a tribal resolution.

Nick, you seem to be on a roll, so here's one more for you. If an institute is listed on the MSI list, does that automatically open up the state territory for eligibility?

No, it doesn't. So, an institution as the MSI if I'm just making sure that as an MSI, you mean a minority serving institution, no, it does not. We would also encourage you to look at the Department of Commerce and BroadbandUSA Connecting Minority Communities Pilot Program, which is a \$268 million grant program to historically black colleges and universities, tribal colleges and universities and minority serving institutions for the purpose of Broadband Internet access Service, and eligible equipment, or to hire and train information technology personnel. That information can be found on BroadbandUSA by searching the Connecting Minorities Communities Pilot Program.

So, the DUNS number, owner is the administrator, despite the submitter government agency. If the telecom service provider is the DUNS owner that makes them the administrator?

Thank you for clarifying question, So, the eligible entities, for example, the tribe, tribal government, etcetera, must submit the application to NTIA. The service provider, if they are not listed as an eligible entity, on page two of the NOFO may not submit the application for this program. The eligible entity will be the grantee, and will be responsible for the grant award.

I hope that clarifies.

Thanks, Crystal.

I'm gonna go back to you. Our apologies. The first attempt to address this question, it wasn't read in full, so the question was, Our tribe is in contact with a

telecom company that has a submarine cable project that is planned to be completed in 2023.

They do not have funds the branch of fiber cable over to our community, but are willing to put a branch T along the run. And from that, we could build a fiber run to our community that could serve as our middle mile.

This opportunity we just reached just last week and therefore not a lot of time to plan details, but the application. We also anticipate FCC approval of our tribal five license application, that can be used for a last mile distribution through our community. Under the current NTIA TBCP application, we asked the following questions and project scenarios. 1.

We study plan for fiber since 2023 is beyond the one-year of this current TBCP to be ready for the next round of infrastructure funding, and also build our 2.5, local distribution infrastructure, IE, tower, equipment, etcetera, during this current funding.

Adam, do you want to address that first? And then I'll read let's, let's start out with that. Yeah, we'll just go one at a time.

49:53

So, can you apply for studies and planning, feasibility? Design engineer?

Adam Geisler

Yeah, of course, those are eligible activities that you'll find on page 32 of the NOFO.

So, that's in line, now, at the same time, you also want to build a 2.5location, distribution infrastructure, tower equipment, etcetera, during this current funding.

I think that there's some challenges in, in this, I think, first and foremost, you're gonna run into a cap on your design expenses of 1%, because you're actually moving into implementation and construction activities, right? The 1% cap isn't applicable if you don't know what you're going to build to or designed to yet, right?

So yeah, I mean, you're looking at a fiber to the community, so essentially, you're running your middle mile to the community, to a distribution point and then deploying that out through 2.5 spectrum.

1:01:11 Doesn't sound like you have duplication of your delineating and then in terms of will you receive the points available for scoring? I mean, you know, of course, we're gonna, as I mentioned before, right, we're going to evaluate all the applications using their criteria that we have starting on page 38 of the NOFO.

1:01:30 Again, we're not looking to penalize anybody that that has good projects. And it's thinking about leveraging multiple resources. So that's probably the best in terms of an answer I can give you on that one.

That if an entity that is not a tribal government is applying for infrastructure grants and infrastructure funding, that they must receive resolutions of support from all tribal governments, that that project goes through. To be clear on that and I will leave you with one word of caution. Which is, you gotta be mindful about duplication. So, we can't duplicate upgrades to backhaul into the future, if that backhaul is supporting 25/3 last mile connections to households unserved households and anchor institutions.

It looks like we gotta follow up on right along that same line Nick. It looks like it. Yep.

It does, but before we go into that follow up question, I'd like to see if our colleague Margaret was able to come back online and can, if, if I may, can Margaret can we test your microphone?

Yes, can y'all hear me?

Yes, we can, thank you and I will transfer the authority vested in me as moderator back to you.

I am so sorry. OK, Adam, the satellite backhaul does not meet the 25/3. The community is still considered unserved, correct?

That's right. If you don't, if you don't have 25/3, or you, don't forget the latency component of that too, right.

That also means the ability to sustain real-time application use, such as we'll give examples right ZOOM. What are we on here? GoToWebinar, Google Docs I mean if you can't function in and in the workspace using these real-time applications and late latency is a factor here. So don't forget that.

You do not have access to 25/3 with sufficient latency to support real-time application use, you are considered unserved by the program.

Thank you. Adam. Gabe what if the available services very expensive service exists, but it's 2 to 10 times the national level, and, therefore, unaffordable.

Well, first of all, welcome back, Margaret. Nick did a great job, but he's not a Margaret.

So in the NOFO it does say that that it provides affordable broadband programs to Native American and Alaska Native Hawaiian communities, including providing free and reduced cost broadband service and preventing disconnection of existing broadband service.

This is under use and adoption, and it would be considered for use and adoption that you can actually have a different way to be able to service your community.

Thank you.

Adam, can you please give an example of commercial grade equipment is listed on page 42 of the NOFO.

Adam Geisler

Let me pull that up really quick.

1:10:22

Sorry, folks! In terms of specific examples, I think that we don't actually give in the NOFO any specific types of equipment.

1:10:51

I think what's important is to look at some of the other facets that that coincide with how we're thinking about commercial-grade: sustainable, scalable, right?

1:11:03

You need to have the capacity capabilities and throughput capabilities to sustain a 25/3 access for households at anchor institutions. And that means that the backhaul that is available is gonna need to be able to be able to support that as well.

So, I also think that probably not the biggest fan of the fact that term isn't here, but, hey, it is so we're not overly prescriptive beyond looking at commercial grade equipment

And making sure that that commercial grade equipment can accommodate sufficient speeds that we're looking for the program, but that is also scalable, sustainable, et cetera. Horrible response, but it's, it's the best we got for you for today.

Thanks, Adam.

1:11:57

Again, Adam, does an applicant, get extra points for providing 300, 300 service with a 15 to 1 over subscription ratio versus one gigabyte per second service, but the 200 to 1 over subscription.

Should all applications outline what the over subscription ratio is? Example, the user experience will be significantly better on the 300 to 315 to 1, then one G on 200 for 1.

Get extra points. I mean we have our point criteria broken out on page 38, and I hate to sound like a broken record.

1:12:42

Everybody's trying to figure out, how do I get more points? It's in the NOFO guys. You see the scoring criteria that we put forward for speed so I'm gonna point you there.

The other thing that I'm gonna mention to you is put forward the best solution that makes sense for you. I mean, it sounds like you know what gives the best user experience for what you're looking at.

And again, we're looking at it, but we are looking at a 25/3 network access.

So, I really can't answer the question beyond, where I just urge you to look at what we're looking at for points you know. Shoot the moon above, even what we have in there. Great.

I mean, that's awesome. We're happy to see it. But at the same time, we have a ceiling, right? If you go above and beyond there, it gets to a point where you're not we don't have a you notice how the scoring doesn't have bonus points, right? We just have straight points.

So in terms of what ratio makes the most sense you need to put forward what the best solution set is. It's going to have the best user experience giving the level of access to make that household unserved.

So, Vanessa, I'm assuming a lot about this question, actually, this is not a funding question, but more business or organizational question, what should happen that, so I'm assuming the question there is, what are their next steps as far as applying for the grant?

Does that work?

So the first thing would be for you to have a grants.gov account.

Just checking to make sure that you have all the documentation as outlined in the NOFO. Nick did a great job earlier, talking about all of the required forms and documentation. So making sure you have all that, depending upon which project type in their infrastructure deployment, or use it in all the supporting documentation that's required and then hitting the Submit button.

But if you have any issues with actual grants.gov, they do have a helpdesk 800 number that you can reach out to them as well, if you are having the IT issue.

We, we have a lot of work in front of the team moving forward, but we've actually had a very similar conversation about the establishment of a tribal leader broadband network, to share best practices, use cases, et cetera. So keep an eye out for that. That is a goal of the team has that we want to pursue.

But, I'm also, if we're being realistic, we also want to get you the money, too. Right, so we're, we're going to navigate our way through that process here to the future.
