18	Criteria for Eligible Recipients	A State must award formula subgrants for a fiscal year by allocating funds in a timely manner to each LEA in the State with an approved Title III plan. Additionally, a State must reserve not more than 15 percent of the State Title III allocation for subgrants to LEAs in the State that have experienced a substantial increase in the percentage or number of immigrant children and youth who have enrolled in schools in the LEA in the current fiscal year compared to the average of the last two fiscal years.
