BEAD Initial Report - Overview



The Broadband Equity, Access, and Deployment (BEAD) Initial Report must be submitted 90 calendar days following the award date of BEAD program grant funds.* The Initial Report should outline planned and actual activities through the date of the report's submission.


Initial Report Requirements

The Initial Report must include the following:

- A description of Planned and Actual usage of funds
- A description of Planned and Actual subgrantee program processes
- Identification of the mechanisms the Eligible Entity intends to use to ensure that all subgrantees comply with eligible program requirements as prescribed by the BEAD Program.
- Any other information required by the Assistant Secretary in any subsequent guidance.

Item to Note:

The BEAD Initial Report will be completed in Salesforce.



*Per Specific Award Condition (SAC) #19, the Recipient shall submit an Initial Report with detailed requirements. BEAD NOFO, Section VII.E.1, can be used as a source of reference when completing the BEAD Initial Report.






BEAD Initial Report – Helpful Hints



The Eligible Entity's designated Federal Program Officer (FPO) can assist with answering questions or concerns when completing the Initial Report.

Helpful Hints

- Ensure the following data elements match the Notice of Award document (CD-450):
 - Federal Award Number
 - Recipient Legal Name and Address
 - EIN Number
 - Award Period Start and End Dates
- Reporting Start Date is the date funds were received by the Eligible Entity.
- Submit the Initial Report 90 calendar days after award date.
- Document significant updates such as changes in scope or delays in planned activities.
- Submit completed reports to assigned FPO via Salesforce.

BEAD Plan Developer and BEA Consultant (\$3,200,000): The State will want to work with a single entity that will both write the required Five-Year Action Plan and provide consultation based upon said plan. BEA believes this will best incorporates the state's efforts for broadband buildout, mapping, digital equity, and ongoing Capital Project Fund work. BEA will extend this resource to our municipalities as a resource for them, which include webinars and other education opportunities. This single, four-year contract will be issued through the competitive Reguest for Proposal process, and will be for four years.

As outlined in the BEAD NOFO, Section IV.B.7, each Eligible Entity must establish fair, open, and competitive processes for selecting subgrantees. Eligible Entities' selection processes must be made clear to potential subgrantees and must be described in the Eligible Entity's Initial Proposal and Final Proposal. As a part of this selection process, each Eligible Entity must ensure that adequate safeguards are in place to protect the integrity of the competition, including safeguards against collusion, bias, conflicts of interest, arbitrary decisions, and other factors that could undermine confidence in the process. An Eligible Entity may choose its own means of competitively selecting subgrantees for last-mile broadband deployment projects, subject to approval by the Assistant Secretary (during review of the Eligible Entity's Initial Proposal). Each Eligible Entity's subgrantee selection process must, however, incorporate the following principles to satisfy the Infrastructure Act's mandates and the BEAD Program's goals: (1) Complete Coverage of Unserved Locations and Underserved Locations, Followed by Prioritization of Eligible CAIs; and (2) Selection Among Competing Proposals for the Same Location or Locations.

In addition, as outlined in the BEAD NOFO, Section IV.C.1.b, each Eligible Entity must include sufficient accountability procedures within its program to ensure subgrantee compliance with all applicable Program requirements. Each Eligible Entity must, at a minimum, include in any subgrant agreement reasonable provisions allowing for recovery of funds in the event of a subgrantee's noncompliance with the BEAD Program's requirements, including but not limited to failure to deploy network infrastructure in accordance with mandated deadlines. 


After Certification, Eligible Entities will submit the Initial Reports to their FPOs via Salesforce.

Reviews will gauge the recipient's level of planning and preparation to address programmatic requirements, such as Environmental and Historic Preservation and subgrantee compliance.
